SUBJECT: APPOINTMENTS AND DESIGNATIONS BY THE BOARD OF EDUCATION

Appointments

The Board is authorized to appoint individuals or organizations to positions which will facilitate the meeting of its responsibilities to the state, the school district, and the community. These appointments usually take place at the annual organizational meeting.

The following shall be appointed annually:

- a) District Clerk;
- b) Board of Education Clerical Support;
- c) District Treasurer;
- d) Deputy Treasurer;
- e) Tax Collector;
- f) Treasurer, High School Extraclassroom Activities Account;
- g) Treasurer, Middle School Extraclassroom Activities Account;
- h) Audit Committee;
- i) Financial Auditor;
- j) Internal Claims Auditor;
- k) Deputy Internal Claims Auditor;
- 1) School Physician/Nurse Practitioner;
- m) 1st Committee on Special Education and Committee on Preschool Special Education;
- n) List of Impartial Hearing Officers;
- o) Legal Counsel;
- p) Employee Relations Counsel;
- q) Cooperative Health Insurance Consortium representative and alternate.

The following must be appointed but need not be reappointed annually:

- d) Liaison for Homeless Children and Youth;
- e) Chemical Hygiene Officer;
- f) FERPA Officer;

The following may also be appointed:

- a) Board Liaisons: BTSBA Legislative Committee representative; Senior High Student Government representative; District Planning Group representative; building liaisons; district-wide Safety Committee representative; Wellness Policy Advisory Committee representative; Board of Education Policy Committee representative; Town liaison; Audit Sub-Committee representative; Program Committee representative(s);
- b) 2nd Committee on Special Education

The following designations shall be made by the Board of Education at the Annual Organizational Meeting in July:

- a) Petty Cash Accounts and Signatories;
- b) Official Newspaper(s);
- c) Official Bank Depositories;
- d) Official Bank Signatories;

Authorizations

- b) Superintendent to approve budget transfers within limits prescribed by Commissioner's Regulation Section 170.2 and Board guidelines;
- c) Superintendent to apply for Grants in Aid (State and Federal) as appropriate;
- d) Other(s) as deemed appropriate/necessary.
