

Dear Community Members, Families & Staff:

Te want to thank you for your support of our students and staff during the past years. We are very grateful that Vestal Central School District has been able to provide a sound education and social experience for our students during this school year by means of a balanced school budget.

Vestal's State Aid figure is comprised of many different categories, including Foundation, Transportation, Building, Excess-Cost, BOCES and Instructional Materials Aid. For the 2023-24 school year, we anticipate receiving a net increase to our State Aid of approximately \$2 million. State Aid is a critical piece of our revenue budget and helps ensure that we can fund our quality programs, maintain our infrastructure, and support our students, staff, and community.

New to this budget adopted by the Board of Education on April 17 and proposed for the 2023-24 school year are an additional School Resource Officer, an Elementary Teacher, Special Education Aide, Special Education Teacher and CSE/CPSE support for our Special Education Office. Further, we are adding coaching and intramural positions to support our student athletes in the areas of Girls Wrestling, Basketball, Track, Unified Basketball and Flag Football. This budget also supports increases to our material and supply lines, transportation, utilities, and other contractual obligations due to inflation and district needs.

Proposition 1 is for the approval of the proposed 2023-24 spending plan in the amount of **\$90,122,447**. The Commissioner of Education issued Regulation 170.8, which requires all school districts in New York State to present their budget information in accordance with a prescribed format. This newsletter follows that format, showing the total proposed expenditure budget in three parts - *Program, Capital and Administrative* components.

In addition, school districts are required to provide an estimate of debt service payments and an estimate of New York State aid displayed as a percentage of the proposed expenditure budget. On the following pages, you will find the school district's proposed 2023-24 expenditure budget presented in accordance with this regulation.



Small Capital Improvement Project - Install garage-style door for accessibility of Robotics Lab at Vestal HS and provide proper floor modifications to support new grant-funded equipment in this lab. Install temperature-control systems in two IT closets at VHS. This small capital project is aided for expenses up to \$100,000.



Ongoing Capital Improvement Project - Install elevator access to Central Junior and the Administrative Offices, in accordance with the Americans with Disabilities Act (ADA). Install another stairwell for emergency egress and additional security for the District's Universal Pre-Kindergarten Program. Phase III is budgeted at \$910,000 this year.

Property Tax Report Card

New York State law and the New York State Commissioner's regulations require that school districts across the state develop a Property Tax Report Card. It must be submitted to the New York State Education Department, as well as made available to the public. School District Budget Notice

New York State law and the NYS Commissioner's regulations also require that school districts mail a School District Budget Notice to all qualified voters in the school district after the Budget Hearing, but no later than six (6) days prior to the school budget vote. The regulations do not provide authorization to school districts to include explanations of the information on the notice. To provide you with a better understanding of the School District Budget Notice, a preview is included on page 7. This Six-Day Notice postcard will be mailed to you before the school budget vote on May 16, 2023.

The annual budget vote for the fiscal year 2023-24 by the qualified voters of the Vestal Central School District, Broome and Tioga Counties, New York, will be held in said district on Tuesday, May 16, 2023, between the hours of 12 and 8 p.m., prevailing time in the Vestal Central Junior Building, 201 Main Street, Vestal, at which time the polls will be opened to vote by electronic voting machine.

School Bus Purchase

The second proposition appearing on the May 16, 2023, ballot would authorize the Vestal Board of Education to issue bonds

to cover the costs associated with the purchase of school buses. Five 70-passenger buses, one 48-passenger bus that can transport four wheelchairs, and one SUV or van are scheduled for replacement in 2023-24. Specifically, Proposition #2 on the ballot will state:

Shall the following resolution be adopted, to wit:

Resolved, that the Board of Education of the Vestal Central School District, Broome and Tioga Counties, New York, is hereby authorized to purchase student transport vehicles to include buses, vans and/or SUVs, including incidental expenses in connection therewith, at a maximum estimated cost not to exceed \$1,250,000 and that said amount, or so much thereof may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District shall be issued.

Vestal CSD's replacement schedule for vehicles is designed to allow for maximum return on the expense for a school bus. Large buses are replaced every 10 or 11 years; smaller buses, every five to eight years. School buses are maintained in strict compliance with Department of Transportation guidelines, and with applicable laws and regulations. In addition, the District receives State aid on the purchase of new buses; the anticipated amount of NYS aid is \$800,000.

New York spreads the state-aid payments over five fiscal years so that only one-fifth of the earned aid is received in a given year. Thus, the District finances school bus purchases over five years in order to match the expenditure with the NYS aid. Ms. Kay Ellis' answers

1. Public school districts have always had to operate within the guidelines, laws, mandates, rules, policies and directives from the State and Federal educational leaders. Any changes should only have a positive effect on the educational program we provide to Vestal students of all capabilities and talents. The District needs to be able to react to any changes in a way that enhances student achievement to the maximum possible.

2. Learning should be a lifetime goal for all. Not only in the classroom, but on the sports field, in the library, on the school bus, in the cafeteria and anywhere that ideas can be exchanged and learning opportunities can be taken advantage of. Staff committed to helping each student reach his or her potential with the support of family will ensure a greater community for all.

3. Maintaining open communications with all stakeholders ensures a successful Board of Education. The educational criteria that must be adhered to should be done in a fiscally responsible fashion. Providing the best educational environment, while bearing in mind the associated costs to the taxpayer, has always been a balancing act.

4. Public school districts will always be faced with challenges, whether it be curriculum issues, financial burdens, staffing shortages, or infrastructure concerns, for example. The last few years have proven that we can survive and move forward against monumental odds. It may not always be easy, but facing any issues head on with the best advice and counsel from experts will ensure Vestal will continue to be a leader in the area.
