SUBJECT: SCHOOL TAX ASSESSMENT AND COLLECTION/PROPERTY TAX EXEMPTIONS

A tax collection plan giving dates of warrant and other pertinent data shall be prepared annually and submitted for review and consideration by the school business administrator to the Board of Education. Tax collection shall occur by mail or by direct payment to the place designated by the Board of Education.

Real property used exclusively for residential purposes and owned by one or more persons, each of whom is sixty-five years of age or over, shall be exempt from taxation to the extent of percentum of the assessed valuation determined by the Board if the owners meet the criteria established annually by the Board.

The real property tax exemption of real property owned by a married couple, when one of them is sixty-five (65) years of age or over, once granted shall not be rescinded solely because of the death of the older spouse so long as the surviving spouse is at least sixty-two (62) years of age.
