SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.

This part of the ESSER funds will be utilized to support the purchase of chromebooks for students. Prior to the pandemic, Vestal CSD was not a 1:1 device district. However, in the last 1.5 years, we have become a 1:1 device district where every student and teacher has access to a chromebook every school day. This allows students and teachers to utilize SeeSaw and Google Classroom applications to reinforce instruction. Also, we have had to instruct some students remotely this school year due to quarantine.

We are also dedicating funds for credit recovery. We recognized that some students did not fare well while on remote instruction last year. The credit recovery program will add teacher support for students after school in order to focus on graduating or moving to the next grade level.

We also have added a Health teacher to directly support students with Social Emotional Learning. We also added an elementary Math AIS teacher. This ensures that we have enough AIS teachers to support struggling students (identified during the pandemic remote instruction period).

Mitigation and prevention strategies include the use of instructional technology for asynchronous and synchronous learning and recovery/tutoring lessons. The additional math AIS teacher is supporting elementary students with learning loss/gaps and current instruction focuses on math skills. The additional health teacher has reduced class sizes in an effort to offer more focused learning with students. Additionally, the health teacher supports our PE and after school programs in an effort to ensure students are current with their grade level learning.

Our credit recovery and tutoring plan is extensive. Students who need support based on attendance issues from the pandemic receive in-person or remote instruction from our teachers after hours.

We are utilizing five week classroom averages and student reports to identify students with academic needs. Additionally, all of our buildings utilize Rtl meetings to ensure all students are identified and plans are implemented to support students. Additionally, grade 3-8 state testing data is available to review.

We also have counselors in each building. Part of their responsibility is to collaborate with teachers and students in regards to academic success.

We run universal screening assessments in grades K-8 in reading and math. This takes place three times a school year. They include the DIBELS, STAR reading and STAR math. We also utilize Fountas and Pinnell running records on a continuous basis. In grades 1 and 2, we monitor phonics with Core Phonics assessments. Finally for K, we utilize the Assessment of Mathematical Understanding (AMU) to gauge student understanding of mathematical concepts.

Utilizing the combined funds from ESSER and CRRSA, we have designated \$350,000 for summer enrichment over three years. These new programs in grade K-12 are essential for targeting learning loss. We are also designating \$180,000 over the three years for credit recovery programs in the middle and high schools.

Both of these are new programs to our district. They have been very successful to date.

We have added a health teacher to the high school in an effort to offer more sections of the graduation requirement. This will support students who failed health class during the pandemic. The health teacher is also supporting PE students who failed PE during the pandemic. This is a key position since we have many students who failed these graduation required courses.

We are also hiring an additional Elementary Math AIS teacher to support mathematics gaps/learning-loss as a result of the pandemic.

6. In the space provided below, please describe how the LEA will spend its remaining ARP ESSER funds consistent with section 2001(e)(2) - the allowable uses of funds - of the ARP Act.

We will be utilizing the remaining funds for teacher and principal professional learning. We know that a well-trained teacher and principal force will equate to an increase in instructional quality in the classroom. We also will utilize some of the funds to offset the lost transportation aid. We drove our buses last summer to deliver instructional packets and to deliver chromebooks to students at their homes. We are also utilizing funds to send teachers/principals to educational conferences. Again, this will support high level instructional practices in our schools.

One recent focus of the district is to build the Southern Tier Robotics Club at Vestal High School. This is a school-based FIRST Robotics competition program. We have many local engineers and two engineering firms that donate their time, knowledge, and equipment to support our students with the building of an annual robot for competition. This project-based learning opportunity benefits our students and staff academically and socially.

We are also adding some field trips to our line. This will allow students to learn beyond the classroom.

We are spending \$50k on upgraded science equipment such as microscopes and VEX kits.

Finally, we are increasing security in our buildings and on our buses by upgrading our camera systems. This is a focus to keep all students and staff safe.

We have activated comprehensive plans for each individual student through our Rtl teams. Furthermore, students with academic concerns have interventions in place that are continuously monitored and adjusted as needed. We are proud of how we educate the whole child. Our students perform well academically and are socially/emotionally sound. Our dedicated teachers, administrators, counselors, social workers, school psychologists, and support staff all focus on student success.

Specifically, we will utilize ARP ESSER funds to train staff in Responsive Classroom, Llfe Space Crisis Intervention, and Non Violent Crisis Prevention training.
