#### **Basic Assumptions:**

- -Tax Levy at Estimated Tax Levy Limit with a 2% growth factor
- -Foundation aid- changes to formula and historical practice
- -Salaries are based on current staff of record with expected contractual increases



# **NYS Executive Proposal**

### **Foundation Aid Changes**

- Removal of "Save Harmless" calculation
  - This removes the provision of the law that states school districts must receive <u>at least</u> what they have in prior year. This means if a district has a change in demographics or declining enrollment the state is going to reduce foundation aid accordingly.

### Change in inflation Figure

- Inflationary increases has historically been based on the average CPI change over previous calendar year, for calendar year 2023 that figure was 4.1%- for 23-24 aid it was 8%
- Proposed change from Governor was to take an average of the last 10 years, dropping the high and low figure which means inflation factor will always hover around 2-3%

#### Removal of Minimum Increase

 No minimum increase but rather a reduction based on removing the "save harmless" as stated above

# **Budget Discussions**

- Tentative Vestal Tax Levy is 1.77% or about \$900K increase over 2023-24 only revenue item proposed to increase
- Currently we are looking at an approximate \$1.7 million deficit for 24-25
- Awaiting the Legislative Proposal- A lot of what the Governor has proposed is un-popular and harms about 45% of school districts in NYS. It is believed that at least 1 of the 3 measures proposed will not make it through the budget process. Removing the "Save Harmless" and the Inflation figure is the most detrimental to our district.
- District is analyzing the following as options to close the gap:
  - Positions that can remain unfilled and or be removed because of attrition
  - Trimming areas of contractual expense and Materials and Supplies expense
  - Possibility to decrease BOCES services or bring services in house
  - Possibility to add BOCES services for things that could then be aid-able
  - Removal of non-essential items from the budget

- -Plan budget timeline and collaborate with BT BOCES CBO

- -Finalize Tax Levy formula
- -Meet with Managed Tech to review BOCES Technology budget
- -Discuss potential areas to cut or restructure
- -Verify and submit final salary projection for 24-25

- -Finalize budget requests and finalize budget concessions
- -Receive and review Legislative Budget
- -Submit balanced budget to the BOE for adoption
- -BOE adopts Property Tax Report Card
